Hearing to Amend Lake Level Order

A petition dated October 10, 2024 was filed with the Hillsdale County Circuit Court to amend the lake level order for Lake LeAnn, including the connected waterways referred to as South Lake LeAnn and North Lake LeAnn. The Hillsdale County Circuit Court will review the petition on the above date, time, and location to receive evidence to amend the lake level order for Lake LeAnn, located in Somerset Township, Hillsdale County, Michigan, consistent with the provisions of MCL 324.30707.

Submitting Testimony and Evidence

The public may submit written testimony and provide evidence regarding the petition and this matter to the Court. The public may also attend the hearing on the above date, time, and location to provide oral testimony and/or evidence. NOTICE OF HEARING TO AMEND LAKE LEVEL ORDER LAKE LEANN

Why am I receiving this notice?

You are receiving this notice because you own lands within the current or proposed lake level special assessment district for Lake LeAnn, including the connected waterways referred to as North Lake LeAnn and South Lake LeAnn.

What is a legally established lake level?

Part 307 of the Michigan Natural Resources and Environmental Protection Act allows circuit courts to establish lake levels for inland lakes to, among other things, benefit property owners and preserve Michigan's natural resources. Lake LeAnn has court ordered summer and winter lake levels under Part 307.

What is a special assessment district?

A special assessment district is an area of land designated to receive special assessments for a particular benefit received from certain public projects, like lake levels.

Will this impact the levels of Lake LeAnn?

No. The intent of the proposed amendments is **not** to impact the physical lake levels that property owners are used to seeing on Lake LeAnn.

Why is the lake level order being amended?

The Hillsdale County Drain Commissioner conducted a comprehensive review of the historical lake level orders in Hillsdale County and found that some require revisions to be consistent with state law and the current operation of the lake level control structures. The lake level order for Lake LeAnn was identified as requiring amendments.

Specifically, the proposed amendments would update the legally lake levels in the order to match the physical levels that have historically been maintained on the lake, update the survey datum to the North American Vertical Datum of 1988 (NAVD88), update the effective dates for the seasonal levels, and clarify that the lake levels are subject to temporary variations due to things like weather and natural conditions. The amendments would also update the special assessment district boundaries to ensure they accurately reflect the properties that benefit from the legal lake levels.

What is my assessment amount?

The court hearing to amend the lake level order will <u>not</u> consider lake level special assessments. A separate public hearing process is required to impose any lake level special assessments on property owners, and all property owners will be mailed notice of the subsequent hearing.

Do I have to attend the Circuit Court hearing?

You are not required to attend the Circuit Court hearing; however, it is your right to do so. You may also present testimony and evidence to the Court regarding the proposed amendments to the lake level order.
